

## Global Forum on Migration and Development (GFMD) Regional Workshop

### **Facilitating social and economic inclusion**

#### **Background**

Ecuador's GFMD 2019 Chairmanship seeks to strengthen the dialogue among GFMD stakeholders at regional level. This workshop will pilot a series of regional events, which will directly contribute to the thematic priorities of the Quito Summit and the development of supporting documents, but also function as standalone events that bring forward the global debate on migration and development, and targeting different stakeholders – local and central governments, academia, civil society and regional stakeholders.

This first workshop will focus on the topic of facilitating social and economic inclusion, representing one of Ecuador's thematic priorities in its 2019 GFMD Chairmanship. The degree to which newcomers can find safety, opportunity and a sense of belonging in a host community is often closely linked to their legal status, and to the sense of safety, opportunity and belonging that prevails among locals in that community. It is therefore critical to address shared needs and to bolster capacities in both groups, ideally to foster a sense of common purpose. This theme is to explore the role of political leadership, policy design, resources, capacities, and of newcomers themselves, in fostering inclusive solutions that generate benefits for and meet the needs of both newcomers and host communities. The discussion seeks to facilitate learning around experiences and good practices, addressing the challenges and opportunities of settlement, including underlying questions such as the provision of adequate housing, healthcare and education, access to work and livelihoods, and interventions to foster social cohesion, prevent discrimination and xenophobia, and tackle labour exploitation.

#### **Objective**

To facilitate the sharing of models and practices that have worked in order to provide inclusive solutions that generate benefits for newcomers and host communities alike with a view to contributing to the Round-table 1.2. "Facilitating social and economic inclusion" of the GFMD 2019 agenda.

## Guiding questions (as per the Concept Note GFMD 2019)

- What are the major obstacles in providing newcomers with access to basic services such as health and education? What kinds of partnerships and innovations can ease existing constraints? How can they promote the operationalisation of global policy developments, for instance in migration health to achieve better health outcomes?
- How do local institutions need to adapt to service the needs of newcomers? How can the costs and benefits be effectively communicated to the local population? How can community participation from all strands of society be ensured?
- What role do newcomers have in facilitating social and economic inclusion?
- How can efforts to generate livelihoods and ensure access to the labour market benefit newcomers and locals alike? How can labour standards and decent working conditions be safeguarded for all workers?
- What practices and partnerships have proven successful in addressing and mitigating mistrust and tensions between newcomers and host communities, and in fostering social cohesion? How can governments avoid the impression of 'favouring' newcomers over host communities? Are there good practices on how to mitigate 'competition' or tensions between newcomers with different backgrounds? What role can individual governments play regarding their diaspora in different countries?
- How have innovations and new ways of doing things that were introduced as part of crisis responses (e.g. in immigration and local service delivery systems) improved service delivery for all users, including host communities? What role can local community stakeholders and newcomers play in co-creating inclusive solutions, for example as co-developers and providers of inclusive health services?

## Expected outcomes

- Experiences, policies and practices on social and economic inclusion across the region are identified and shared by the participating countries;
- Analysis of the current situation with the identification of practical, innovative and emerging practices and solutions in relation to social and economic inclusions;
- The outcomes and findings of this event will be fed into the Background Paper of Roundtable 1.2 of the GFMD 2019 Summit.
