Dear GFMD Friends of the Forum,

The Government of the Republic of Ecuador has assumed the 2019 Chairmanship of the Global Forum on Migration and Development (GFMD) from 01 January until end December this year. This signals the second time that the GFMD Chairmanship has returned to Latin America since 2010.

Our GFMD Chairmanship coincides with the first year of the implementation of the two Global Compacts -- one on Refugees (GCR) and the other for Safe, Regular and Orderly Migration (GCM). Hence, as set out in the GFMD 2019 Concept Paper, the Ecuadorian GFMD Chair proposes an agenda that is both forward-looking and introspective. Ecuador aspires in its Chairmanship to nurture common ground amongst Member States and to strengthen dialogue with traditional GFMD partners – international organizations, civil society and business -- and welcoming new stakeholders, particularly local authorities and researchers.

Based on the proposed work plan and thematic agenda for the year 2019, and in accordance with the GFMD long-term financing framework, the Ecuador GFMD Chair proposes a core budget of Two Million Four Hundred-Thirty Thousand, and Six Hundred Seventy-Eight United States Dollars (USD 2,430,678), comprised of the following cost elements:

A more detailed overview of the projected expenses is provided in Annex A. As described therein, the proposed budget includes the costs of various preparatory activities leading to the Twelfth GFMD Summit in Quito in November 2019, as well as other GFMD initiatives aimed at generating greater awareness about the GFMD process and its outcomes, in Geneva, New York and the regions.

The Final Meeting budget provides a rough estimate of the main cost elements associated with the organization of the Twelfth GFMD Summit in Quito. It will be adjusted as plans are firmed up in the coming months. The third main component of the core budget is the GFMD Support Unit operational budget, which covers the costs of dedicated staff and resources needed to provide admin and logistical support for the proposed activities in the GFMD 2019 work plan, administer and reinforce the GFMD Platform for Partnerships, implement the GFMD communication strategy, and manage the GFMD database. Finally, there is a 5% contingency provision for unforeseen expenses.

In addition to the core budget, an amount of Four Hundred Thousand US Dollars (\$ 400,000) needs to be raised in order to provide the GFMD with a seed funding upon the assumption of the GFMD 2020 Chair. This is in line with the Long-Term Financing Framework of the GFMD which has been adopted since 2014. Thus, the total required resources as of end December 2019 are estimated at USD 2,830,678.

The GFMD Chair will include a voluntary pledging session during the meetings of the Steering Group and the Friends of the Forum, to call upon all participating member states, particularly the members of the Steering Group, to demonstrate their support by offering financial contributions to the GFMD process and to the Ecuadorian GFMD Chair.
